## **Cooperation Agreement “CUPAGIS University - Enterprise”**

### **PARTIES TO THE AGREEMENT**

This is a cooperation Agreement among the consortium members of “CUPAGIS”, hereinafter referred to as “University” on the one hand

Hereinafter referred to as “Partner”, aiming at dissemination, implementation and development of the results of CUPAGIS, as well as creating opportunities for employment of students of University on the basis of the cooperation between University and Partner within the framework of this Agreement.

### **SUBJECT OF THE AGREEMENT**

The PARTIES will joint their efforts aiming implementation, dissemination and developing of the results of CUPAGIS, particularly in the field of improvement of training high qualified specialists as well as in research activities.

For this purpose, the PARTIES agree on the following activities:

#### **1. University:**

- a) Will share with Partner information about the above project as the up-to-date timetable of Project activities and teaching /training aids developed during the Project
- b) Will add information about implemented activities of this Agreement on the web portal of the University and the Project web portal <https://www.cupagis.eu>
- c) Will invite specialists of Partner to participate in the expert quality assessment of modernized and new curricula, which are implemented in University according to the CUPAGIS project plan, during the period of their modernization/development and the pilot teaching. The quality assessment schedule should be coordinated between University and Partner.

## **2. Partner:**

- a) Will study the information derived, develop a plan to adopt and implement at teaching or/and to improve training of graduated professional staff
- b) Will participate in CUPAGIS activities, in action on implementation and dissemination of project results (self-reliant actions, if possible joint actions with University), may participate at master classes/conferences of CUPAGIS in the frames of the Project
- c) According to the agreed plan will inform University about Partner's needs in new employees/specialists, the available internship possibilities for students, available master and PhD topics. Partner will participate in the questionnaires, prepared by University to determine the actual knowledge requirements of graduates (young specialists). Partner will provide support to University
- d) Provides internships for bachelor, master and PhD students of University. During such internships, students will get a chance to receive professional experience, improve their skills and orient themselves in the demands and needs of the job market, write final thesis and dissertations on the basis of Partner. Partner will provide assistance in formulating the topic of the research and completing the paper. Partner will assist in the successful employment of students after the completed internship and thesis defending.

3. Every institution of the PARTIES will nominate a person (contact person) in charge exchanging information and carrying out obligations of this Agreement.

4. Partner is expected to participate in the joint educational/scientific network. To realise this PARTIES can draw up needed organisational bilateral document and contracts on mutual Agreement.

5. PARTIES will confirm to be ready to cooperate through joint participation in different international and national projects and programmes on education, research and others.

## **6. GENERAL CONDITIONS**

### **6.1 Agreement terms**

This Agreement enters into force after signing and is valid 5 (five) years, being possible to be prolonged. Every member can leave 3 (three) months after having sent an advice note to every other member.

6.2 All the attachments and supplements to the Agreement will be valid and enter upon duty only written and signed by both PARTIES.

6.3 In case PARTIES are not able to meet for signing the Agreement or its supplements, the signing procedure may be carried out through exchanging scanned papers via email.
